



# THE FACTS ABOUT FAMILY SUPPORT

**TROUSDALE COUNTY**

Begun by the Division of Mental Retardation Services (now the Division of Intellectual Disabilities Services) in 1988, the Family Support program was formally established by the General Assembly in 1992. Family Support is a flexible, family-friendly program that supports Tennesseans with all types of severe disabilities to live in their own homes and communities. Family Support is a very cost-effective program that prevents many people from needing more expensive programs.

## THE PEOPLE

- Family Support served 4,144 individuals statewide in FY 09
- Maximum allowable per person is \$4,000 in direct aid each year. **The statewide average in direct aid per person was \$1,420 in FY 09**
- 6,363 families were on the statewide waiting list at the end of FY 09
- **22 families were served in Trousdale County in FY 09**
- **Average of \$919.55 direct aid per family in Trousdale County**
- **0 families were on the waiting list in Trousdale County at the end of FY 09**

## THE PROVIDERS

Family Support Services are provided in all 95 counties by private nonprofit agencies. The agencies are guided by local volunteer councils. Agencies receive a small state funding allocation to staff and operate the program. Communities often supplement state dollars with local in-kind services and supports to families.

## THE FUNDING

- Statewide funding reached its highest level (\$7,679,400) in FY 05 and remained at that level until January 2009, when funding was reduced to \$6,665,237.
- Funding for FY 10 was further reduced to \$6,364,237.
- Prior to FY 10, funding came from state general appropriations. However, all but \$200,000 of funding for FY 10 will come from economic stimulus recovery funds.

## A COST-EFFECTIVE SOLUTION

Family Support is the least expensive of all programs that provide home and community-based services to people with any type of developmental disability. The total (direct costs plus program operations) average annual cost in FY 2009 for each person served was only \$1,608.
